

Cheltenham and County CC Parental Agreement and Medical Consent Form



This document is for the parents or guardians of riders under the age of 18 wishing to participate in our club rides. Our rides are suitable for those who can ride unsupported for two to three hours at a moderate pace and over a distance of approximately 30 miles for road rides, 15 miles for MTB Introductory rides.

Young riders need to be pre - vetted prior to the initial ride and they must follow the leaders instructions at all times.

Medical Information

Please note below any **relevant** medical information you feel we should know about (e.g. asthma, allergy) in the case of an emergency.
